The maximum number of individual event competitors will be 40 (i.e. doubles count as 1, team jump count as 1). Tournament participation will be filled on a first come, first served basis. **The registration will close at 9:00am on Friday, July 29, 2016. If any items are missing at the close of registration, the competitor(s) will be ineligible to compete in the Individual Competition.** No refunds will be issued. Seeding is as follows: 1st & 2nd place finishers from the previous year (if competing) will ski in the last 2 positions. All others will ski in the order of random draw. The starting order will be posted immediately following tournament registration. Each competitor is responsible for having music via CD, electronic, or digital storage.

Plaques will be awarded to 1st, 2nd, & 3rd place for each event.
